**Minutes of Annual General Meeting 23<sup>rd</sup> January 2011**

**Apologies:** Apologies for absence were received from Kevin Robinson, Tricia Outrim & Jackie Atkinson.

1. Brian Page opened the meeting at 10 30 welcoming everyone to the AGM.
2. **Chairman's Report:** Brian presented the Chairman's address, explaining the difficult year the Committee had experienced with a general lack of information from HQ as they too are through a troubled period which has seen the loss of the Media Officer and a number of other roles during the course of the year. 2010 had been another difficult year financially for the Association borne out by the lack of support for our Fund Raising efforts as people continue to prioritise their spending.

Brian went on to say that our sport has seen a further reduction in the number of Sanctioned Leagues in the County, we now have just 5, of which 2 are YBCs, our current membership stands at 84 (adults and junior/adults, with a further 12 Junior members). Our County teams experienced mixed fortunes over the year, with the Senior teams enjoying the greatest success with both teams reaching the Finals in Peterborough. The ladies team finished in 6<sup>th</sup> place, whilst the Men's team won the Silver Medal, coming runners-up to Yorkshire whose ladies team also took the Gold Medal. Brian thanked Gerry & Derek for all their hard work throughout the year, despite the difficulties both remained very positive throughout the year, he also passed on thanks to Alison & Paul who stepped into the breach in October to organise a fund raising competition and raffle over the Xmas period and raised over £100 for the association which was excellent.

3. **Treasurers Report:** Brian then asked Gerry Olver to present his Treasurer's report; the accounts as at the 23<sup>rd</sup> January shows the Association with a bank balance of £284.72p, and based on similar expenditure to last year's entry fees/lineage for our County teams the Association has a projected short fall of £430, which we would need to 'plug' by fund raising activities. Gerry also pointed out that the Association owed Derek £108 for the cheque he wrote on the 12<sup>th</sup> September in relation to the hire of the DVD's for the October Race Night which was subsequently cancelled, receipt had been provided. A cheque for that value was passed across to Derek. So the final year end balance was effectively reduced to £176.72p.

On a brighter note Alison raised awareness that she expected to receive a donation from one of the members for £300, which will go some way to plugging the gap between what we have and our projected spend over the year.

#### **4. Elections**

Brian then chaired the following elections:

Prior to Christmas Derek had advised the team that he would not be seeking re-election, and then in January Gerry also let it be known that he too would not be carrying on either.

**Area Secretary:** Gerry Olver proposed Brian Page, seconded by Homer Joseph, there were no other nominations and Brian was duly elected.

**Inter County Co-ordinator:** The current ICC Kevin Robinson was more than happy to continue in the role and was re-elected unanimously.
